

## Prepaid Health Plan (PHP-Medicaid) denials Tips:

- Please allow 30-45 days for the PHP to follow up on your claim once you have reached out to them.
- Call and check on your issue with the PHP.
- If you are not receiving follow-up or issues are not corrected in a timely manner you need to contact Medicaid Provider Ombudsman.
- Make sure you received a ticket from Medicaid Provider Ombudsman
- Reach out to your Administrative consultant for guidance (we have to have a ticket to move forward with DHB).

## Coding & Billing Guidance for Monkeypox for Local Health Departments

As of August 3, 2022

The following has been identified to use when providing specimen collection and vaccination for Monkeypox. As more information is provided from the Centers for Disease Control (CDC) and American Medical Association (AMA) this guidance will be updated.

These codes may not be reimbursed by third party payors (at this time) but may be used in your electronic health record for reporting purposes.

#### Monkeypox

Monkeypox is a viral disease infecting primates and rodents. Its clinical presentation in humans is similar to smallpox including fever, headache, cough, and a painful rash. It is caused by monkeypox virus and is usually transmitted to humans through bites or via contact with an animal's blood. Interhuman transmission is relatively low (significantly less than smallpox).

#### Program Assignment

- Monkeypox testing should be assigned to the Communicable Disease program or the Sexually Transmitted Disease program (if patient is being tested for other STIs based on the patient's presentation)
- Monkeypox vaccination should be assigned to the program in which the patient presents, is identified as
  meeting the criteria for vaccination and the vaccination is given at that visit. (AH, PC, FP, etc.)
- Monkeypox vaccination should be assigned to the immunization program if that is the sole reason for the visit.
- If Monkeypox vaccination is being provided as follow-up to a diagnosed case of Monkeypox in that individual, then the program assignment would be Communicable Disease.

#### Cost of Monkeypox Testing & Vaccination

NC Local Health Departments should not charge for testing or vaccine administration for Monkeypox.

#### ICD-10 Coding for Monkeypox

CDC and AMA have not released ICD-10 coding guidance. Providers should code to the highest level of specificity.

#### Specimen Collection:

CPT: 99211 (Specimen collection OR E/M code as appropriate if seen by provider)

SUBJECT: Billing Medicaid for use of 340b drugs/devices

In June 2008 a memo was issued by Dr. Joe Holiday, Women's Health Branch and Dr. Joy Reed, Local Technical Assistance & Training Branch to provide instruction related to averaging the cost of drugs, specifically birth control pills. This guidance was continued in the October 2015 memo issued by Belinda Pettiford of the Women's Health Branch. This memo, dated March 5, 2020, supersedes all previous guidance related to billing Medicaid for drugs/devices purchased under the 340b drug pricing program. This memo is not intended to address drugs/devices purchased outside the 340b drug pricing program.

In September of 2019, NC Medicaid issued clarification on their billing policy to reiterate that drugs/devices purchased under the 340b drug pricing program and billed to NC Medicaid must be submitted at the actual purchased drug/device price in the usual and customary charge field. ### What is 340B?

The 340B Federal Drug Pricing
 Program expands access to affordable medications to low-income populations by supporting the operations of healthcare safety net providers.

### Fees for 340B Drugs & Devices

 LHD's are required to bill Medicaid the acquisition cost of medication or devices purchased via the 340b drug program.

> AVERAGING THE COST OF 340B DRUGS IS NOT ACCEPTABLE

UD Modifier

### Fees for 340B Drugs & Devices

 LHD's are allowed to bill their usual and customary charges to all payors other than Medicaid (agency decision)

## **340B Pricing List**

Normally sent quarterly to your LHD's

Make sure you review the price list

 Make sure you keep up with your 340B stock and purchase price

## What is your process to ensure acquisition cost?

 All LHD's should have a process in place to ensure you are billing acquisition cost at all times.

 You are not allowed to average cost it must be acquisition.

 Who in your LHD's is part of this process?
 (Purchasing, Nurse, Billing) this will depend on how you have this set up in your LHD's.

### 340B Drug Eligibility

 Requires that the client receive a 340B eligible service on the date the 340B drug is provided and that drug and service must be documented in the chart.

## 340B Billing Guidance

 Family Planning 340B drugs/devices may only be used in a client that meets the Family planning 340b patient definition on the date the drug/device is prescribed/administered /dispensed.

### 340B and your Policy

 Make sure you place 340B in your eligibility and fees policy

## 340B Drugs and Devices

- County Health
  Department bills Medicaid the
  acquisition cost of medication or
  devices purchased through the 340B
  drug program. All 340B drugs and
  devices are identified with a UD
  modifier in the
- billing system.

  340B drugs and devices are billed to Medicaid with an FP and UD modifier. The appropriate NDC code must also be included. Drugs and devices purchased through the 340B program are labeled as 340B and stored separately from other medications and supplies.
