- Permanent subsidy reimbursement rate increase
- Decouple private tuition and subsidies
- Effective- July 1, 2023



# Kids Mental Health

- *H605, School Threat Assessment Teams* signed into law July 7
- Line items in both Senate, House, and Conference report budget proposals





## S20, Care for Women, Children, and Families Act.

- Prohibits abortion after 12<sup>th</sup> week of pregnancy

- Nurse midwives scope of practice

## **Medicaid Expansion**

**383,000 children** in North Carolina have at least one uninsured parent. With the expansion of Medicaid, that positively impacts not only the parents but the children in the households.



#### **Postpartum Medicaid Extension**

The new extension of Medicaid benefits to postpartum people from 6 weeks to 12 months will help reduce maternal deaths, infant mortality and promote healthy development among approximately 24,000 babies born each year.



### **ARPA Advocacy**

Local advocates in Guilford County successfully advocated for \$1 million of ARPA funds to go towards hiring school nurses. Approximately 72,000 students will benefit as a result.



#### Lowering the Lead Hazard Level in Children's Drinking Water

The recent revision of the definition of a lead hazard in children's drinking water in the Childhood Lead Poisoning Statute from 15 to 10 parts per billion extends lead exposure protection to more than 30,000 young children, particularly in child care settings.
