ENVIRONMENTAL HEALTH SECTION NCPHA, Inc.

The Environmental Health Section, NCPHA, Inc. (formerly the Sanitation Section from 1939 until 1969) had its origin in the old Presbyterian Church in Greensboro, N.C., in 1939. At that time, Mr. J. M. Jarrett proposed a change to the NCPHA Constitution whereby all members of the health units would be eligible for membership within their own designated scientific section. It is only fitting to point out that no single person has meant so much to the organization and promotion of the Environmental Health Section, NCPHA, Inc., as has Mr. Jarrett.

In 1940 the NCPHA meeting at Pinehurst provided for the creation of scientific sections and revised its constitution accordingly. Thus the Section was born. The first official meeting was during the NCPHA meeting in 1941 at Pinehurst.

Within the Environmental Health Section, NCPHA, Inc., five component district organizations were created within the framework of the Section. Each district has individual leadership and their own constitution. Presidents of each district along with the Officers of the Section comprise the Executive Committee of the Environmental Health Section. For the purpose of interchanging ideas and methods of sanitation, the Section was affiliated with those of five other states and the District of Columbia into a unique, loosely organized confederation called the Interstate Environmental Health Seminar (formerly the Interstate Sanitation Seminar). In 1963 the Section became affiliated with the National Environmental Health Association.

In 1959 the General Assembly enacted a Sanitarian Registration Act (90A) which legalized the professional status of the qualified sanitarian in North Carolina. On June 22, 1982, the General Assembly ratified House Bill 964, "An Act to Amend the Laws Regulating Sanitarians". This Act repealed Article I of Chapter 90A of the General Statutes and amended Chapter 90A, thereby setting up a new Board of Sanitarian Examiners. This landmark legislation prescribes who may qualify as a sanitarian intern, qualifications and examination for registration as a sanitarian, as well as, who may, or may not, practice as a sanitarian.

This is the Environmental Health Section, NCPHA, Inc., affiliated with the National Environmental Health Association, which is composed not merely of outstanding leaders, but is firmly anchored in the team concept of all for one and one for all.
