NEW SCHOOL OF PUBLIC HEALTH DEAN



On September 1 Dr. Bernard G. Greenberg will succeed Dr. W. Fred Mayes as dean of the School of Public Health of the University of North Carolina.

Dr. Greenberg has served as head of the Department of Biostatistics since its inception. In this position he has shown continuing interest in the health needs of North Carolinathrough teaching Biostatistics to many health workers of the State in regular academic as well as short courses, collaborative research with other health professionals on problems in the State, and consultation for state and local health agencies. At the same time he has built a national and inter-

national reputation in the field of Biostatistics.

A long-time member of the North Carolina Public Health Association, he has served as chairman of several of its committees and had an important role in the establishment of the Statisticsidemiology Section of the Association. He has also served as airman of the Statistics Section of the American Public Health Association, and in 1966 received the Bronfman award of the national Association for outstanding accomplishments in public health.

As dean-elect, Dr. Greenberg has stressed his interest in having the School of Public Health participate in various future health efforts in North Carolina. He has expressed this in a motto, "Think North Carolina." He has also indicated the hope that the future mission of the School will include undergraduate training that will eventually reach many North Carolina students, and work on model health centers to bring together public health training and practice in localities within the State.

Treasurer: Ralph H. Boatman, Professor of Health Education and Administrative Dean of Allied Health Sciences, University of North Carolina; formerly Vice-President of NCPHA.

Members-at-Large: Verna Y. Barefoot, M.D., Health Director, Craven and Pamlico County Health Departments, and Becky S. Bowden, Coordinator, Community Fluoridation Program, Dental Health Division, North Carolina State Board of Health.

NCPHA LEGISLATIVE PROGRAM

The Legislative Committee of the Association has suggested and the Governing Council has approved proposals that NCPHA:

1. Take appropriate action on legislation developed by the Legislative Study Commission on the Organization and Delivery of Public Health Services.

2. Formulate and introduce legislation, in cooperation with other agencies of local government, to eliminate modification of salaries downward by local government and to bring into effect state-wide use of the State Personnel Board Pay Plan without exception.

3. Support or introduce legislation to give the North Carolina State Board of Health authority to determine specific immunization requirements.

4. Initiate legislation to allow delivery of family planning services to minors without parental consent.

5. Introduce legislation enabling county governments to remove junk automobiles.

6. Support amendments to the Nurse Practice Act and/or Medical Practice Act to enable specially trained nurses to perform legally in a variety of settings.

The selection of items of proposed legislative action followed extensive efforts of the Legislative Committee to obtain suggestions from NCPHA members throughout North Carolina. The Committee asked each county health department, as well as other public health institutions, to designate a representative who could apprise the committee of local member concerns and suggestions for resolution of health problems. Fifty-six counties sent names of volunteers who furnished an impressive number of issues for Legislative Committee consideration and gave reactions to proposals made. These persons will provide liaison with local legislators as the NCPHA legislative program develops.

As part of the NCPHA legislative program Dr. Marjorie Strawn, chairman of the Legislative Committee, made a presentation to the Legislative Study Commission on the Organization and Delivery of Public Health Services on needs for assistance of local health programs in order to provide better distribution of health services throughout North Carolina.

SHORT COURSE ON PUBLIC HEALTH LAW

Frank P. Grad, professor at Columbia University Law School, will be principal instructor and Dr. James R. Kimmey, executive director of the American Public Health Association, will be a featured speaker for a short course on Principles of Public Health Law and Legal Tools for Effective Health Administration at the Ramada Inn, Greensboro, North Carolina, February 20-23.

Designed primarily for employees in local public health agencies, the course has the sponsorship of the North Carolina Public Health Association, the Southern Branch of the American Public Health Association, the North Carolina State Board of Health, and the University of North Carolina School of Public Health. Miss Elizabeth S. Holley, chief of the Public Health Nursing Section, North Carolina State Board of Health, is chairman of the planning committee for the course.

Brochures giving additional information about the course will be mailed to NCPHA members in October. Traineeships will be available for 75 persons.

Subsequent general sessions will include presentations on "The Public Health Profession and Environmental Protection," by Professor Emil T. Chanlett of the Department of Environmental Sciences and Engineering at the University of North Carolina, and "The Government and Environment in North Carolina," by Dr. Arthur W. Cooper, Assistant Secretary of the North Carolina Department of Natural and Economic Resources.

Representative Nancy Chase, chairman of the North Carolina Legislative Study Commission on the Organization and Delivery of Public Health Services, will speak at the final general session. She will give the Association members some of her observations on recent activities of the Commission which are of considerable potential importance in meeting public health needs of the people of the State.

NEW ACTION BOARD PROPOSED

NCPHA members will be asked to vote at the Annual Meeting on a proposal to create a new action board within the Association. The Development Study Committee made the proposal and the Governing Council has approved it.

The purposes of the proposed new board would be to elicit issues and problems relating to health, to study the effects of identified problems on the health of the people, and to recommend priorities for action. Sections and committees of NCPHA, as well as individuals and outside groups, would make suggestions to the board. which would in turn make recommendations for the Governing Council to take selected positions on issues or perform other actions. The Council would refer approved recommendations to Association committees for implementation when appropriate.

The new board would be representative of education, research, programming, planning, legislation, and personnel, and would include the APHA Action Board correspondent. The board could also form task forces composed of experts, from within or without NCPHA, to research particular issues. Comprehensive data obtained in such studies would serve as a resource to Association committees and sections.

Presentations and discussions at the Annual Meeting and the Newsletter would provide means of informing members of work of the Action board and involving them in such work.

The intent of the organizational change is to assist NCPHA in dealing with problems and issues relating to the health of the citizens of North Carolina within the existing structure of the Association.

SUGGESTED CHANGE IN NCPHA BY-LAWS

The Governing Council has approved for submission to the Association members a recommendation of the Nominating Committee for a change in the By-Laws aimed primarily at enlarging the panel of persons eligible to serve as NCPHA officers to include recent chairmen of standing committees. Specifically the recommendation is for a change in the requirement of Article VI Officers that

"An officer shall be a member of APHA and shall have been a member of the Governing Council of NCPHA."

to

"An officer (1) shall be a member of APHA and (2) shall have been a member of the Governing Council of NCPHA or chairman of a Standing Committee of NCPHA during the past ten years."

PROGRAM SUMMARY 60th ANNUAL MEETING, NCPHA, 1971

"Look to the People—Our Best Resource" was the theme of the 1971 NCPHA Meeting and spot-lighted the contributions of a variety of groups to public health in North Carolina. The 60th Annual Meeting, October 6-8, was held in Winston-Salem at the new Convention Center.

Dr. James Kimmey, executive director of APHA, identified in his keynote address that APHA was again the "cutting edge" for progressive health legislation at the national level. He reminded the session that historically APHA had been in front, leading health and political interests toward better means to meet health needs. Dr. Kimmey stressed the need for affiliates of APHA, such as NCPHA, to make their opinions known. In summary he stated that APHA was committed to active stands on pertinent issues and that all of public health was urged to join with them.

Senator Hargrove Bowles (having just announced his candidacy for governor) and John Jordan, NClegislative representative, PHA's spoke of legislators' and state executives' interest in public health dur-ing their discussion of "Legislative Process and Public Health in North Carolina." Both avowed that health was a timely issue in the state political and bureaucratic arena and that actions would be taken. They challenged public health workers to share their knowledge and opinion with legislators. The major message was to get commitment on issues from candidates during primaries and elections, and to concentrate work in the General Assembly at those times when issues were alive. Both these men acknowledged the impact of work of NCPHA members during the previous General Assembly, gave cogent reasons for lack of complete success of NCPHA programs, and encouraged the Association to continue its efforts.

Members of the Association, outstanding professional persons and volunteer workers were honored for their service to public health during the Honors and Awards Banquet.

The closing session focused on community involvement in health today, particularly planning and consumer (Continued, p. 4 column 2)

MESSAGE FROM THE PRESIDENT

Public health in North Carolina in 1972 should be a time of tremendous excitement and perhaps even adventure. When has there been so much interest in health, especially in such areas as the environment, safety, family planning, delivery of health services, and programs for children, drug addicts and alcoholics? Legislators and consumers, the affluent and the poor, providers and clients, industrialists and insurance people. . . so much concern. And a new state agency—what will the Department of Human Resources be? The profes-sional public health worker anticipates that his intimate knowledge of community problems will be utilized and that public health agencies will be provided by the resources to respond to the demand for services.

The NCPHA has set itself the task of becoming a spokesman in public health in North Carolina. The Legislative Committee will work with NC-PHA members and with our Legislative Representative, John Jordan, to identify the key health issues which demand legislative activity. And with Mr. Jordan's help, work will begin while the primaries and elections are in process to obtain commitment of legislators to issues. When the 1973 General Assembly convenes we will be prepared to aggressively support selected issues. All of us recognize that political decisions are determined by contacts at the local level and our members are out there!

ANNUAL BUSINESS MEETING SUMMARY

Mrs. Jean Lassiter, President, presided. Serving as Parliamentarian was Mrs. A. H. Borland of Durham, a member of the National Association of Parliamentarians.

The membership stood for a moment of silence during the reading of the names of the members who died during the past year.

The audited Financial Statement was presented by the Treasurer, Mrs. Maxine Matheson, indicating a balance of \$13,154.24.

Barbara Kahn, Secretary, read a summary of Executive Committee and Governing Council actions (exclusive of that on membership, reported elsewhere). Highlights are as follows:

The Executive Committee nominated Margaret Dolan for President-Elect of APHA and sought support for the nomination from the 17 Southern Affiliates of APHA and the State Directors of Health in the Southern Branch Region. (Mrs. Dolan was subsequently elected to this office.) Others nominated to APHA posts were Dr. Jacob Koomen, Jesse Canady, Dr. John Hughes, and Dr. Martin Hines.

The Governing Council adopted the recommendations of a committee studying our relationship with Southern Branch, APHA, to wit that NCPHA subscribe to the higher dues structure recommended by Southern Branch, and further, that NCPHA membership cards indicate that NCPHA membership automatically includes membership in Southern Branch, APHA.

The Scholarship Committee, with \$2,405 available for distribution awarded a total of \$2,150 divided among seven NCPHA members for assistance in pursuing graduate study in public health. The Executive Committee approved the Committee's recommendation that the \$800.00 allotted yearly for scholarships be increased, pending review by the 1972 Budget Committee.

Three resolutions of the Manpower Committee affecting local health department personnel were adopted. In brief, these recommended (1) that the NCPHA Action Board and the State Board of Health seek to bring about increased fringe benefits; (2) that the Action Board and Legislative Committee take appropriate action toward changing N. C. statutes so as to eliminate the modification of salaries downward, and adopting the plan approved by the State Personnel Board; and (3) that an additional staff member be employed by the Personnel Section of the State Board of Health to help that Section meet its responsibilities to local health departments.

tinue its lobbyist program in connection with the 1973 General Assembly, and approved the recommendation that John Jordan be retained as Legislative Representative.

An Association Development Study Committee was appointed with Dr. E. A. Pearson, Chairman, to recommend organizational changes in keeping with an action-oriented purpose.

The following change in the Association By-Laws was voted upon and adopted by the membership at the Annual Meeting:

"All nine members of the Legislative Committee shall be appointed for two-year terms beginning at the end of the North Carolina legislative year. The chairman shall be appointed by the President at the time of the total committee appointments to serve a two-year term."

Clark Edwards, Chairman of the Membership Committee reported that records had been searched to find persons eligible for Life Membership. He read the list of those so honored.

BY - LAWS

ARTICLE I MEETINGS

1. There shall be at least one meeting each year, held at a time and place to be selected by the Executive Committee. This meeting shall consist of at least two sessions, both of which may be held on the same day, if practicable. All persons in attendance shall have the privilege of the floor.

2. Special meetings of the Association may be called at any time by the Executive Committee, and shall be called by them upon the written request of fifty Active Members or Members of the Association, two of whom are members of the Executive Committee.

ARTICLE II QUORUMS

n Selation and a selation seat

1. A quorum of the Association shall consist of not less than fifteen active members, two of whom shall be officers of the Association.

2. A quorum of the Executive Committee shall consist of four members.

ARTICLE III DUES

1. The following constituents shall be exempt from the payment of annual dues: Life Members, Honorary Members, Active Members and Members who have been affiliated with the Association for 25 years or more and who have been retired from active duty, and Active Members and Members who have been affiliated with the Association for thirty years regardless of retirement.

2. Active membership and membership dues shall be \$2.00 per annum, payable in advance, January 1, effective January 1, 1960.

3. Sustaining memberships dues shall be \$50.00 or more per annum, payable in advance, January 1. an an an Arthree

4. Life membership dues shall be \$50.00 payable within one year after election.

ARTICLE IV

COMMITTEES TO BE APPOINTED BY THE PRESIDENT

1. <u>Auditing Committee</u>: Shall consist of three members, who are not officers of the Association, whose duties shall be to examine and audit annually the books of the Treasurer, and report their findings at each annual meeting.

2. <u>Membership Committee</u>: Shall consist of a Chairman appointed by the President, one member from each organized Section of the Association appointed by each Section Chairman, and the Treasurer of the Association, who shall be an ex-offico member; shall be named each year as soon as possible following the annual meeting; shall see that new members of the Executive Committee and chairmen of the committees of the Association become Active Members before becoming active in the work of the Association; shall receive all applications for membership, pass on eligibility, and elect Members; shall refer the names of eligible applicants for Sustaining membership and Life membership and nominations for Honorary membership to the Executive Committee for election; shall notify the Treasurer of the names of individuals who are exempt from the payment of annual dues; and shall conduct campaigns when necessary or take such other steps as may seem advisable to bring members into the Association. Any applicant failing of election in the manner just provided for shall have the privilege of withdrawing his application, or ef having it acted upon by the Association at its next annual meeting.

3. <u>A Nominating Committee</u>: Shall consist of one representative of each Section who shall recommend to the Association candidates for election to the several offices of the Association.

4. <u>The Awards Committee</u>: Shall consist of the Dean of the School of Public Health at the University of North Carolina, Chairman; the State Health Director; six members-at-large appointed by the President; and the President of the North Carolina Public Health Association, Ex-Offico. Persons appointed to membership on the Awards Committee shall be notified of such appointment by the President. This Committee is to consider all nominations for the Carl V. Reynolds Award to an individual, the Watson S. Rankin Award to an individual, the Merit Award to a Health Department or other organized group, and any other recommended awards that may be available. This Committee will submit its recommendations to the Executive Committee of the North Carolina Public Health Association, which has the responsibility for conferring awards. The areas represented on the Awards Committee may be added to as indicated.

5. <u>A Legislative Committee</u>: Shall consist of two members from each organized Section of the Association and two members-at-large. One member from each Section and one member-at-large shall be Active Members of the Association. Each member shall be appointed for a four year term and appointments shall be staggered to provide overlapping of membership according to the following plan: On each odd-numbered year one appointment shall be made from each of the following sections: Health Director, Sanitation, Secretaries, Nutrition; on each even-numbered year one appointment will be made at large and one from each of the following sections: Public Health Nursing, Health Education, Laboratory. Appointments made to fill vacancies caused by resignation or death shall be for the unexpired term of the resigned or deceased member.

The Chairman of the Committee shall be appointed by the President of the Association, preferably from among those members of the Committee serving their third year. The function of the Committee shall be to study and make recommendations to the Executive Committee and to the Association regarding legislative matters and to assist the Executive Committee in all matters soncerning legislation. The Legislative Committee shall have the power to approve or disapprove items selected by the State Legislative Council for the legislative program of the council.

6. <u>Convention Planning Committee</u>: Shall consist of the Vice-President of the Association, Chairman; Secretary of the Association; the State Health Director; and two members-at-large, who shall serve for two years each with overlapping terms, one being appointed each year by the President. For the first year the two members-at-large shall be appointed one for one year and one for two years. The function of the Committee shall be to select two years in advance the convention dates and site and submit its recommendations to the Executive Committee for approval, so that an announcement may be made at the forthcoming convention of the meeting dates and site of the next succeeding convention.

7. <u>Budget Committee</u>: Shall consist of the President and Treasurer of the Association and three additional members of the Association, who shall prepare a budget for the Association.

8. Committee to Study Personnel Problems:

9. The President may appoint such <u>Other Committees</u> as he may deem desirable with such functions as he may determine.

ARTICLE V RULES OF ORDER

Business sessions of the Association shall be conducted in accordance with Robert's Rules of Order.

ARTICLE VI PUBLICATIONS

All publications of the Association shall be issued under the direction of the Executive Committee, and shall become the property of the Association.

ARTICLE VII PROPERTY

The Executive Committee shall act as trustees for all property of the Association.

ARTICLE VIII SCIENTIFIC SECTIONS

A Scientific Section may be created at any annual session by majority vote of the Association, provided the application for the creation of such section has been submitted to the Executive Committee and the creation of such section recommended by the Executive Committee. Sections shall elect their own officers. They shall conduct sessions in cooperation with and under the supervision of the Executive Committee.
