This Committee studied ways of increasing membership in the NCPHA---by promoting the benefits of membership---by increasing the *benefits* of membership. The following suggestions or proposals were presented to the Governing Council:

1. during the Legislative session, Mr. Jordan report weekly to the NCPHA President, and the information be passed to the members by means of the newsletter.
2. investigate the possibility of publishing the Newsletter more often
3. the NCPHA brochure be revised
4. that the Governing Council request the Governor to proclaim a week in February as N.C. Public Health Week, with an all out effort to promote Public Health and membership in NCPHA, soliciting the support of the Division of Health Services and local health departments

In 1976 the Governing Council requested that all section chairmen check membership before admitting persons to a section business meeting, the Membership Committee requested that the Governing Council make an effort to control admittance to the Association business meetings and to social functions provided for members and paid guests.

The committee heard reports from section membership chairmen who are successfully recruiting members.

NCPHA membership cards will be checked against section membership rolls with follow up by respective chairman.

We discussed the possibility of offering benefits for members, i.e., agreement with business firms to give price reductions to members. The committee requested that the Governing Council take action on this so that this may be pursued or abandoned.

Re: The *Categories of Membership*, the committees make the following motion to amend the Student Member eligibility to read: Student membership shall be offered to any full time student, meeting the other membership requirements.

It was pointed out that there are many full time students who could be active in the Association, but the two-year limit for students tends to discourage involvement.

## FEATURED SPEAKER



Mrs. Agnes C. Higgins

Mrs. Agnes Higgins of Montreal, Canada will be the featured speaker for the Nutrition Section meetings on Wednesday and Thursday during the Annual Meeting. She is being sponsored by the National Foundation-March of Dimes for her visit to North Carolina in September.

If any member is interested in maternal and infant health, you will have a chance to meet a pioneer in the field at this year's NCPHA Annual Meeting. Mrs. Higgins provided some of the first solid documentation of the health benefits to babies from maternal nutrition rehabilitation through her work in the Montreal Diet Dispensary. Her program used concepts, later adopted in the United States, for the WIC Nutrition Program, now active in half of the North Carolina's counties.

Active in U.S. Maternal nutrition policy planning, Mrs. Higgins will speak on Quality Control in Human Reproduction: Maternal Nutrition and the Outcome of Pregnancy."

## SOUTHERN BRANCH AMERICAN PUBLIC HEALTH ASSOCIATION

The Forty-Fifth Annual Meeting, Southern Branch, American Public Health Association was held April 19-22, 1977, Camelot Inn, Little Rock, Arkansas, in conjunction with the annual meeting of the Arkansas Public Health Association.

Dr. Dorothy M. Talbot, R.N., Ph.D., School of Public Health, Chapel Hill, North Carolina, served as president of Southern Branch during the past year. Dr. Talbot did a superb job in all areas of organizing and demonstrating leadership in carrying out the activities of Southern Branch. Those of us who attended from North Carolina were very proud of her accomplishments especially she being from North Carolina.

The Governing Council met on Tuesday afternoon April 19 and transacted business on an eighteen item agenda plus reports from fourteen committees.

The theme of the program was "*Operation Update*" - a continuing education and training conference to increase competency for public health workers. At the opening General Session on Wednesday morning, Mary Howard Smith presented a paper on "A Look at Continuing Education for Public Health Workers" ... the academic viewpoint. Helen Scott Swain presented a paper on the practitioner's viewpoint. Both speakers gave very timely and informative information on Southern Branch's role on continuing education. Southern Branch plans continuing education to be a top priority for affiliates.

The Honorable David L. Pryor, Governor, in his remarks of welcome announced that he had declared Public Health Week in Arkansas for the annual meeting of Southern Branch and the Arkansas Public Health Association.

A Memorial Workshop Day was devoted to Elizabeth (Lib) S. Holley. Lib served as president of Southern Branch in 1965 and was one of North Carolina's most devoted members and supporters of Southern Branch.

Fred Hering of the A.P.H.A. office in Washington made a few comments, one of which was the planning of twenty workshops on new and innovative practices in public health law, engineering, medical services, environmental health and alcohol.

Dr. Carl Brumback, immediate past president, discussed and explained the role of the Southern Health Foundation, Inc., a subsidiary of Southern Branch and a non-profit foundation. The Southern Health Foundation, Inc. is involved in carrying out programs in the following areas:

1. Community-based hypertension control program
2. Needs of Florida visitors for physician services
3. Florida pre-natal intensive care program
4. Improving health care assessment
5. M.A.S.T. west central Florida
6. Carcinogenic potentialities of farm and industries
7. Quality health care for short term penal institutions

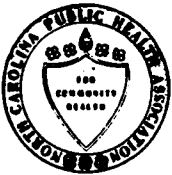

### REPORT OF THE LEGISLATIVE COMMITTEE:

#### 1. Health Aid to Counties:

Health Aid for local health departments will be submitted to the General Assembly in a supplemental budget. The Department of Human Resources is requesting (in the supplemental budget) a total of \$9 million for the biennium 1977-79 for local health departments. The N. C. Association of Local Health

The Governing Council will meet in Greensboro on May 17, 1977. If you have concerns as an individual member that you would like to see brought before this body, please contact me or your section chairman. Don't leave everything up to "NCPHA". Remember YOU are NCPHA. An organization can only be as strong as its members make it. Take an interest in your association and make it a vital force speaking out for public health in North Carolina.

Directors is working with DHR on this revised budget and information will be sent to all local health departments in the immediate future. The Legislative Committee will keep you informed about the progress of this legislation.

#### 2. Local Pay Plan:

On March 2, 1977 the State Personnel Commission approved the third draft policy change for Local Pay Plans giving the county commissioners "control flexibility." The policy passed was considerably improved over the one discussed at the January 19, 1977 meeting, due in great part to the concern expressed in hearings by the NCPHA, N. C. Social Services Association, N. C. Mental Health Association, N. C. Association of Local Health Directors, and the N. C. Association of Social Services Directors. The Commission announced that the supporting data requested by NCPHA will be made a part of the regulations adopted to implement the local pay

policy. This coalition will continue to function throughout this legislative year and will introduce legislation to expand the State Personnel Commission from seven to nine members by adding two local government employees.

Two state government employees are presently members of the Commission. Each NCPHA member is encouraged to support this legislation to let your legislators know of your support. Report any difficulty with the new Local Pay Plan to the Legislative Committee or Executive Committee of NCPHA.

Day Care Coverage Injunction was ratified by the General Assembly February 8, 1977. A summary of the bill from the Daily Bulletin is as follows:

"Amendment adopted in House 1/26/77 rewrites proposed GS 110-04 (injunctive relief) to specifically authorize superior court to grant temporary preliminary, or permanent injunctive relief for violation of article or rules and regulations promulgated by Child Day-Care Licensing Comm'n which threaten serious harm to children in facility, and to specify that Secretary of Administration may seek injunction when administrative proceedings are pending" . . .

#### 4. Health Services to Minors:

House Bill 370 was introduced by Representative Hunt of Orange County on March 9, 1977 and was referred to Judiciary III Committee. A summary of the bill from the Daily Bulletin is as follows:

"Rewrites GS-90-21.4 to provide that licensed North Carolina physician or person under his direction and supervision not liable in civil or criminal action for providing 'health services' to minor without consent of parent, guardian, etc. (now, similar except applies only to protect 'physicians' administering 'treatment' from 'damages'), to protect such persons from civil liability 'on the basis of minor's representations' for good faith provision of services, to specify that liability for negligence remains, and to forbid physician from notifying parent of provision to minors of services described in GS 90-21.5 without minor's permission. Rewrites GS 90-21.5 to authorize provision of health services relating to venereal and communicable diseases, pregnancy, drug and alcohol abuse, and emotional disturbance (now, similar provision applies only to venereal and reportable diseases) and to specify that only minor, and not parent or guardian, is liable to pay for services that only minor consents to. Deletes provision of GS 90-21.5 stating that minor 18 or older or emancipated may consent to treatment for self or child. Effective July 1, 1977, but does not apply to pending litigation."

The House Judiciary III committee held a hearing March 22, at which 11 organizations appeared in support of HB 370. Dr. Jesse Williams, Cumberland County Health Director and member of the NCPHA Legislative Committee was spokesman for NCPHA and Local Health Directors. Dr. Sarah Morrow, Secretary of the Department of Human Resources, appeared in support of this bill. There was no opposition voiced at this hearing. From all appearances, the committee will give a favorable report. The Legislative Committee urges you to contact your Representatives and Senators and voice your support for HB 370.

## REPORT OF THE BYLAWS COMMITTEE, NCPHA:

Proposed Revisions of the Bylaws of the Nursing Services Section North Carolina Public Health Association January 11, 1977.

### Present Article VI: Duties of Officers:

The Treasurer shall (1) keep a record of any and all funds of the Nursing Services Section and shall disburse funds on the order of the Chairman, the Executive Committee or on a majority vote of the members of the Nursing Section.

### Proposed:

**ADD: and (2) serve as Chairman of the Finance Committee.**

Rationale: The Finance Committee is a new standing committee to be created.

### Present Article VII: Committees

There shall be four standing committees of the Nursing Services Section.

The Program Committee (and its functions).

The Awards Committee (and its functions).

The Membership Committee (and its functions).

The Nominating Committee (and its functions).

Proposed: Change four to five (italics)

Rationale: The creation of the new standing committee will bring the total to five standing committees.

### NEW:

The Finance Committee shall be composed of the Nursing Services Section Treasurer, who by virtue of the office shall serve as Chairman of this Committee, and two (2) section members (including members of the section branch) who shall be appointed by the Finance Committee Chairman.

The Finance Committee shall receive direction from the Executive Committee. It shall (1) review the previous year's budget and anticipate expenditures, (2) prepare a proposed budget for the Nursing Services Section, (3) recommend to the Executive Committee the Nursing Services Section dues, (4) submit the proposal to the Executive Committee in January for adoption.

### Rationale:

The Section treasurer has expressed a need for a Finance Committee to help in decision making and in drawing up a budget as a guide for anticipated annual expenditures.

Providing costs for honorariums, mementos, and luncheons for guests and/or speakers and other incidental expenditures are items that are increasing in cost.

### Present Article VII: Dues

The dues for this section will be one dollar (\$1.00) payable by each member of the section annually prior to February 1. Dues statements will be mailed to each member by the treasurer one (1) month in advance.

**Proposed: The dues for this section will be payable by each member of the section annually prior to March 1. Notification of dues will be mailed to the Section Treasurer one (1) month in advance.**

### Rationale:

The amount of dues will be proposed by the Finance Committee and recommended to the Executive Committee for its adoption. Omitting a stated amount as in our present bylaws would eliminate the expense and time-consuming process involved in amending the bylaws to change the annual dues rate when a change is proven to be necessary.

**ADD: to present Article VII—dues.**

Seventy-five per cent of the Nursing Section Aide Branch dues shall be returned to the Aide Branch.

### Present Article IX: Amendments:

These Bylaws may be amended at any annual meeting by a two-thirds majority vote of the members present, entitled to vote and voting, provided the proposed amendments have been approved by the Executive Committee of the Nursing Section.

**Proposed:**

Change Nursing Section to Nursing Services Section.

Add: and further, provided that the proposed amendments have been approved by the Bylaws and Manual of Procedures Committee of the NCPHA.

**Rationale:**

The addition is necessary to comply with the Bylaws of NCPHA. The Bylaws and Manual of Procedures Committee of the NCPHA "studies proposed changes in Section and Affiliate Bylaws and recommends approval or suggested changes to the Executive Committee."
