Message from the President



I am excited about being President of the North Carolina Public Health Association (NCPHA). I feel those who attended the Annual meeting know I am enthused with my role in NCPHA and about the things that NCPHA can do to help the people of North Carolina. We are a great organization and we are on the threshold of becoming even greater.

One of the first things I have done as President of NCPHA is to look at the objective of our association to understand why we exist. Following is the objective of NCPHA:

The objective of the NCPHA is to protect and promote the Public Health (personal and environmental) of the citizens of North Carolina by:

- 1. Providing Public Health workers in North Carolina with a medium for continued training, education and peer exchange as a means of increasing professional identity and performance in Public Health practice.
- 2. Supporting legislation favorable to Public Health and the promotion of Public Health of the citizens of North Carolina.
- 3. Promoting programs and/or projects deemed necessary to protect and promote the Public Health of the citizens of North Carolina.

The above objective developed in 1969 outlines a goal for our year. The objective provides the basis for all of our work in NCPHA and as long as we keep the objective as our goal, we will seek out and develop policies and programs which will meet our public health dreams.

It is also important to remember the seal of NCPHA and what it stands for as we embark on a new NCPHA year. The seal was designed and adopted in 1958. The official seal is blue on a white field and it represents honor, purity, and sincerity of purpose. The seven dogwood (state flower) blossoms represent the original Sections of the North Carolina Public Health Association. The Tarheel is represented by the pine cone atop the shield. The circling bands represent the cooperative spirit and unity of purpose of the whole program—"Community Health."

I recently returned from the American Public Health Association Annual Meeting which was held in Chicago, Illinois. While discussing public health with my peers from across the nation, I discovered how blessed we are in North Carolina with a great public health system. Both our local and state public health programs and our School of Public Health in North Carolina are considered some of the best. We have the largest Public Health Association in the country with well over 2,000 members. We have probably done more in North Carolina on responding to the Institute of Medicine's report on The Future of Public Health than any other state in the union. The activity and response to The Future of Public Health has been tremendous in our state and as a result I am sure we will be seeing many positive outcomes. The Public Health Study Commission adopted by the North Carolina General Assembly is also a great achievement.

Even though we have many blessings, we have many things we still need to do. In recent years we have witnessed increases in infant mortality in North Carolina. Tuberculosis, which technically should not exist in our society, still is a major problem. AIDS and HIV continue to threaten the people of our state and our only way of battling this disease is through education. Prevention in all areas of public health continues to loom as one of our major responsibilities for the future. We need to promote public health within the new Department of Environment, Health and Natural Resources in order to gain the total support of the new department's leadership. Cardiovascular disease, cancer and injury still rank as the three big killers in our society. We have much work to do.

One of our greatest efforts in the coming two years will be the employment of staff for NCPHA. We are seeking to secure the necessary revenues to employ staff. With the success of a grant and contributions from the North Carolina public health family, we will employ someone in 1991 to take the staff leadership role for our association. This is one goal I will personally be working toward to my fullest ability.

Earlier in the year, through the leadership of the North Carolina School of Public Health, public forums were held throughout the State to allow individuals to voice concerns regarding public health issues and make recommendations for needed change. The overall message at each forum was that our present system is working, but if it can be made to work better, why not do it.

The major goal of the 1989 program subcommittee was to provide additional resource information for continued self-assessment leading to planning and implementation of productive changes in North Carolina. A motion was made and seconded to accept the Resolution for AIDS Education.

Linda Parker gave an update on Legislative Actions. Karen Willett reported that NCPHA had a membership of 1,509. Ballot boxes were placed in different locations of the auditorium for the election of officers.

NCPHA AWARDS: 1990

The NCPHA Awards Committee is now accepting nominations for the following awards for 1990:

A: Reynolds Award: The Reynolds Award is bestowed upon the individual member of NCPHA who has made the greatest contribution to public health in North Carolina during the past year.

B: Norton Group Award: The Norton Group Award is given to a group for outstanding cooperation and service to public health in North Carolina during the past year.

C: Watson S. Rankin Award: The Rankin Award is given to an individual in recognition of outstanding contributions or professionals who have made significant contributions to public health in North Carolina over a period of several years.

D: Distinguished Service Award: This award was established in 1953 to recognize individuals in other organizations or professions who have made significant contributions to public health in North Carolina.

E: Citation of Merit: This award was established in 1954 to recognize outstanding accomplishments of individual members of NCPHA.

F: Service Pins: Service pins are awarded for completion of twenty-five years of full time work in public health, or related field, in North Carolina by December 31st of the preceding year. Years taken from health service for education or military leave are counted if the service is otherwise continuous.

PUBLIC HEALTH CONFERENCE

The Elizabeth Holley Scholarship

NEW AWARD PLANNED BY PUBLIC HEALTH WEEK COMMITTEE

Public Health Week 1990 will be held the week of April 1-7, 1990. World Health Day, which falls on April 7, coincides with this special event.

The Public Health Week Committee is changing its awards for 1990. In the past, three awards were given: (1) the Outstanding Public Health Achievement Award; (2) the Citizen's Involvement Award, and (3) the Outstanding Board of Health Award.

The first two awards went to health departments and the third went to a local board of health. In 1990, however, the Board of Health Award will not be presented by the Public Health Week Committee; it will be a separate award presented by the Association of Local Boards of Health during its annual meeting.

As of 1990, the Public Health Week Committee will offer an award for an innovative event implemented during Public Health Week. This award will be presented to two local health departments each year. There are no restrictions on either the innovation or the uniqueness of the event. However, the event should foster Public Health Week's goal of involving community citizens and organizations in both public and private sectors and raising public awareness of and support for public health services. Award winners will be selected on the basis of local health department feedback information.

The winning health department(s) will receive a plaque and a certificate for either a \$150.00 credit for a one-time purchase of Public Health Week merchandise or \$100.00 to cover expenses for a future Public Health Week activity. The award will be presented to the winning health department at the health department itself. This will allow for full staff participation, as well as that of invited local leaders and the media.

REPORT FROM LEGISLATIVE COMMITTEE

Two top priority goals, the establishment of an independent Public Health Study Commission and consolidation of state health and environmental programs into a new department, were among NCPHA legislative goals approved during the 1989 General Assembly.

NCPHA initiated the bill that established the 21-member **Public Health Study Commission**, charged with studying public health services in North Carolina and recommending improvements. Members appointed by Senate President Pro Tem Henson Barnes are Senators Ollie Harris, Russell Walker, Jim Ezell and Paul Smith; Carl Durham, of the Association of N.C. Boards of Health; Maye Gurley, Wayne County health director; and Richard House, UNC School of Public Health.

Governor Jim Martin appointed Dale Simmons, Surrey County Health Director; Percy Sears, former commissioner from Guilford County; George Rudy, deputy director of the Department of Environment, Health and Natural Resources; Jeff Long, consumer representative from Fayetteville; Jim Fulgrum, Wake County physician; and William Drake. Speaker Josephus Mavretic appointed Representatives Betty Wiser, Howard Barnhill, Charles Cromer, and Theresa Esposito as well as Chris Mansfield, a Greenville physician.

The Department of Environment, Health and Natural Resources combines many health programs formerly in the Department of Human Resources with environmental programs from the now defunct Department of Natural Resources and Community Development. Former congressman William Cobey, Jr. was appointed secretary of the new department, the first Cabinet-level agency created in the state since 1977.

NCPHA's top funding priority, for local environmental health programs, will receive \$300,000 each year of the biennium. No additional appropriations were included for expansion of health promotion and disease prevention programs. No state funds were appropriated for AIDS prevention and education; however, the General Assembly did specify that \$290,000 of a larger federal block grant must be used for this purpose.

More successful were efforts to increase **funding for maternal** and child health. Effective January, 1990, Medicaid coverage for pregnant women and infants will be expanded to include persons with family incomes up to 150 percent of the federal poverty guidelines. In October, 1989, children under age six with family incomes equal to or less than the federal poverty guidelines were covered for Medicaid benefits; in October, 1990, this will include children up to age seven. In addition, \$260,000 was appropriated for the Infant Mortality Prevention Campaign, a program to promote the importance of early continuous and good prenatal care. The Rural Obstetrical Malpractice Fund also received continuation funding.

A bill initiated by NCPHA to add local government employee representation to the State Personnel Commission was ratified, specifying that one of the two County Commissioners Association appointees be a local government employee hired under the State Personnel Act.

NCPHA's goal for a **statewide solid waste management plan** was accomplished in the comprehensive Solid Waste Management Act of 1989. This major rewrite of the solid waste law also includes directives for disposal of used oil, scrap tires and various medical wastes.

The Legislative Committee will work this year to plan strategies for NCPHA's goals that can be considered in the 1990 short session. New section representatives joining the effort this year include Ann Heimer, Public Health Management; Sussie Sutton, Health Education; Nick Engel, STD Section; Kay Brandon, Social Work; Liz Fredrick, Nutrition; and Richard House, member-at-large.

AMERICAN PUBLIC HEALTH ASSN.

The theme of the 117th Annual Meeting of the American Public Health Association, held in Chicago on October 22-26, 1989, was "Closing the Gap: Ethics and Equity in Public Health." Key issues discussed at this meeting were: health equity for women; the poor and minority groups; access to health care for the uninsured and underinsured, seniors, and AIDS patients; and ethics in environmental responsibilities and world health.

A resolution has been developed by APHA on what should be included in a National Health Program, with Congressman Waxman as the sponsor of the Resolution. As of October, there were 16 co-sponsors in the House of Representatives; however, none were from North Carolina. [Give me a call at (919) 761-2390 if you would like a copy of the Resolution and wish to write your congressman. The Resolution number is 760.]

The Year 2000 Health Objectives for the United States are being developed and the Model Standards for public health services will be tied directly to the Objectives. The Year 2000 Objectives will be the theme of the 1990 APHA Annual Meeting in New York, September 30 through October 4, 1990.

The recipient of the APHA 1989 Presidential Citation was Studs L. Terkel, author and a staunch advocate for the protection of the environment.

Faye Wattleton, President of the Planned Parenthood Federation of America for the past eleven years, received the 1989 Award for Excellence. Before becoming President of Planned Parenthood, Ms. Wattleton was a public health nurse and a nurse midwife.

Myron Allukian, Jr., D.D.S., M.P.H. is the current President of APHA and C. William Keck, M.D., M.P.H., Health Director in Akron, Ohio, was elected President-Elect.

SOUTHERN HEALTH ASSN.

At the March, 1989 meeting of the Southern Health Association (SHA), held in Louisville, Kentucky, the Governing Council established a special retirement membership category at 50% of current membership rate, with student rates to be the same as retirees. Some state affiliated associations have developed a retirement group or section to retain retirees in the associations; many have remained active. We may wish to consider this in North Carolina.

SHA will meet with South Carolina on May 23-25, 1990, in Myrtle Beach; with Alabama on April 24-26, 1991, in Huntsville; and with Arkansas in May, 1992, in Warm Springs.

The SHA gives the following five awards: (1) Special Meritorious (2) Ross (3) Charles G. Jordan (4) the Ficuett-Holley and (5) Outstanding Legislator Award. Beth Joyner, Richard Nugent, Estelle Fulp, and Barbara Ann Hughes have been recipients of these awards in past years. If you would like to nominate someone, submit the nomination to Louis Thayer, Awards Chairman, by January 1, 1990.

SHA is working hard to present an active program when it meets with each state. A leadership conference will be conducted along with a public health forum on a current regional public health issue. SHA would again like to extend an invitation for North Carolina to meet with them, possibly in 1993.

I presented a report from Estelle Fulp, NCPHA's representative to SHA, which I have available for anyone interested. There was much interest in North Carolina's new department of Environment, Health and Natural Resources as well as NCPHA's development fund for hiring a full-time Executive Director.

There are many dedicated, conscientious and concerned public health workers in the Southern Health Association and the affiliated states. I personally believe NCPHA could learn a lot from SHA if we would become more actively involved. I suggested that SHA try to become the health arm of the Southern Governor's Association. I would like to recommend that NCPHA continue our affiliation with the Southern Health Association.

APHA FIGHTS FOR LEAD POISONING PREVENTION FUNDING*

Despite the fact that the U.S. has eliminated lead from both paint and gasoline, lead poisoning continues to be a serious health problem for some 3-4 million American children living in homes with lead pipes and walls painted with lead-based paint. For this reason, APHA has spearheaded an effort this year to obtain funding for the newly established Lead Poisoning Prevention Program.

The American Public Health Association, in coalition with the Children's Defense Fund, the National Safety Council, the American Academy of Pediatrics, the Association for Retarded Citizens, the Environmental Defense Fund, and numerous other national organizations, is actively lobbying Congress to provide \$22 million for the Centers for Disease Control's Lead Control Program. Senator Arlen Specter (R-PA) and Representative Louis Stokes (D-OH), influential members of the Senate and House Appropriations Subcommittees with jurisdiction over this program, are championing this cause.

Key APHA members and affiliates, local health officials, and others concerned about lead have worked in concert to obtain the necessary funding. Phone calls, letters, and one-on-one office visits with Members of Congress and their staff have helped educate the lawmakers about the serious nature of the lead problem in the United States.

ASSOCIATION OF N.C. BOARDS OF HEALTH

The Association of North Carolina Boards of Health (ANCBH) received state wide recognition this fall, signified by the appointment of Carl Durham to the Public Health Study Commission. Mr. Durham's appointment enhances ANCBH's position to influence future legislative activities on behalf of all local public health departments.

The association's Annual Meeting was held in Charlotte on September 17, 1989. Board of health members and health directors from 24 counties/districts joined members of the Public Health Week Committee and Dr. Ronald Levine for a luncheon honoring the winner of this year's health week award. Cleveland County health department was recognized for involving private practitioners in mammography and dental programs for health care indigent clients.

Participants at the annual meeting learned how boards of health can participate in the Future of North Carolina's Public Health. A panel presentation gave participants information on advocating for health, educating legislators, and linking resources within counties and the state. Following the panel, small groups used case study examples to illustrate principles of good policy-making.

EDUCATIONAL OPPORTUNITIES

SYMPOSIUM ON ENVIRONMENTAL CHANGE

The University of North Carolina at Chapel Hill will present a symposium January 21-24, 1990, in Chapel Hill on environmental changes expected to occur during the next 10 to 50 years and the impact on public health and public policy.

Discussion will focus on frequent exposures to hazardous pollutants and wastes resulting from increased urbanization, industrialization and technological changes; and changes in home and work environments leading to increased exposure to air pollutants and toxics.

The symposium will include presentations by William Reilly, administrator, Environmental Protection Agency; David Rall, director, National Institutes of Health; Steven Schneider, noted scientist and author; and F. Sherwood Rowland, whose study of chlorofluorocarbons earned him the 1987 Charles A. Dana Award for pioneering achievements in health. Other speakers will include experts from the World Bank, Population Council, Harvard University, Mt. Sinai School of Medicine, University of Iowa College of Medicine, University of Colorado, State University of New York, and University of North Carolina at Chapel Hill.

This symposium—one of several events planned for the school's 50th anniversary year—highlights the leadership role that the UNC School of Public Health plays in bringing the most up-to-date research to bear on critical public health issues that face practitioners, academicians, researchers, and policy makers.

MASTERS IN HEALTH ADMINISTRATION OFFERED

The University of North Carolina at Chapel Hill is accepting applications for its Regional Master's Degree Program for working health professionals and administrators. The program, which is offered through the School of Public Health, awards the Master of Public Health degree in Health Administration and Dental Public Health. The next class will be admitted in May, 1990.

The school is also making plans to begin a new class in Wilson in the Off-Campus MPH Program serving eastern North Carolina in August, 1990. The Off-Campus Program awards the MPH degree in Public Health Nursing and in Health Administration.

The non-residential MPH Degree Programs make part-time graduate study available to health practitioners interested in health policy and administration. The programs require 39 credit hours for graduation and are usually completed in 3 to 3½ years.

Interested persons are urged to begin the application process as soon as possible. Experience has shown that it may take as long as 3 months before all college transcripts, GRE scores and recommendations are available to the admissions committee. Applicants who do not have a current GRE score are encouraged to register for the exam at the earliest opportunity. This exam is administered statewide on February 3, April 21, and June 9.

PRESIDENT'S MESSAGE



The year has passed very quickly, and in just one month I will be handing the gavel over to Bob Parker, our President-Elect. Bob has done a great deal of work for the Association this year and is well qualified and prepared to assume the office of President.

In fact, it has been a busy time for all our officers, members of Governing Council, and Committee Chairpersons. Barbara Chavious has put forth special

effort to make the newsletter stimulating and informative. Doris Gothard has worked long and hard to organize a Program for our Annual Meeting that is going to be superb. Lillie DeWitt and Randall Turpin have faithfully executed their duties as Secretary and Treasurer. Maida Dundon, Estelle Fulp, and Jimmie Rhyne have represented us well with the American Public Health Association and the Southern Health Association. Susan O'Brien and the Nominating Committee have developed a dual slate of officers. Section chairpersons and Committee chairpersons have made significant contributions toward making NCPHA a more effective organization. A special thanks goes to Libby Stephens for "single-handedly" revising our by-laws!

In the January newsletter, I listed some major activities for the Association this year. It's important that you be kept informed about the progress that has been made.

1. Think Tank Task Force Activities and Recommendations

In 1988, the Think Tank Task Force, under the leadership of Leslie Brown, recommended to Governing Council certain strategies that would enhance NCPHA's role in supporting and promoting public health. Governing Council approved these recommendations. One strategy involved the hiring of professional staff to sustain the activities and lobby for the priorities of the Association. Since then, a Professional Staff Development Fund has been developed within the Association's budget, and \$5.00 from each member's dues are deposited into that Fund. The Think Tank Task Force has developed a proposal, for foundation funding, to financially support staff for a short period of time. In addition, Bob Parker has organized an effort for a one-time solicitation of donations from the membership for the Fund. At the May Governing Council meeting, we heard from Jeff Todd, the Executive Director of the Illinois Public Health Association. Jeff was hired through grants and donations but now earns money through various ways to support his salary. We were most impressed with how Jeff has strengthened the Illinois Public Health Association.

The Think Tank Task Force is in the process of completing recommendations on the duties of the President-Elect and on a process for nominating and electing officers for the Association. All of the activities of this Task Force will be processed through Executive Committee and Governing Council and will be brought to the full membership at our annual meeting. Leslie and his Task-Force members deserve our full gratitude for their fine work.

2. Legislative Activities

Linda Parker has done a remarkable job promoting NCPHA's legislative agenda this year. At the time of this writing, we are not certain of the progress we have made. By the time you read this article, we will know. A great deal of lobbying has been done for the creation of a new Department of Health and Environment and a Public Health Study Commission; as well as for increased funding for environmental health, maternal and child health, health promotion, and STD programs. Also, NCPHA has representation on a task force convened by the N.C. Association of County Commissioners to review the issue of local government employee salaries.

3. IOM Report Activities

Four seminars dedicated to the Report have been held across the state. At least one member of NCPHA Executive Committee was present at each seminar. Also, the Report will be addressed at our annual meeting. I feel comfortable that NCPHA will play a vital role in deliberating the impact of the Report on the future direction of public health in North Carolina.

Being President of NCPHA has provided a wonderful experience for me. I now have a more precise appreciation of the importance of the public health system for *all* the people of North Carolina. I am more sensitive to the necessity of *all* of our services and *all* of our public health workers. The active participation of NCPHA in promoting public health is vital. WE MUST BECOME STRONGER! AND WE WILL!

The health care system, if it is to provide comprehensive coverage to all citizens of North Carolina, is complex, challenging and diverse. Over 400 people participated and voiced their opinions through the four statewide forums on the implications of the IOM on public health. These

William Browder from the School of Public Health, will present this timely report.

The Program Committee is most enthusiastic about the opportunities being offered through these dynamic speakers and topics. The presentations will provide information for greater insight in planning, organizing and advocating for positive changes in our system.

REPORT OF THE BY-LAWS AND MANUAL OF PROCEDURES COMMITTEE — PROPOSED CHANGES

The By-Laws and Manual of Procedures Committee will recommend to the membership that the following changes be made in the By-Laws at the Annual Meeting. These changes have been approved by the Governing Council:

NUTRITION

The Nutrition Section awaits the outcome of the *Practice Act* for *Nutrition/Dietetics*. The Nutrition Section became involved with this bill, which secures the safe practice of nutrition and dietetics in NC by requiring licensure of dietitians and nutritionists, in 1987. The bill has been open to comment and discussion with the NCPHA Governing Council and Legislative Committees, state, regional, and local staff.

The Legislative Committee continues to monitor the licensure bill and will keep the Nutrition Section membership informed.

The Nutrition Section will hold a luncheon business meeting on Wednesday, September 13, 1989 on opening day of the Annual NCPHA meeting in Charlotte. Ms. Lynn Hoggard, Nutrition Education and Training Coordinator with the NC Department of Public Instruction, will join us on Thursday, 1:30-3:30 pm, to discuss the school lunch program.

SEXUALLY TRANSMITTED DISEASES

The STD Section has much to look forward to this year at NCPHA's annual meeting in Charlotte. As always, it will feel good to see all the old familiar faces, renew friendships, and swap shop-talk. As many of you well know, shop-talk among STD Section members has always ranged from seriously informative to heroically outrageous. None of us should want to miss this yearly reunion and are hopefully all ready to share our story of the year!

The Executive Committee has planned two programs that we hope section members and guests will find both educational and responsive to current concerns in Sexually Transmitted Disease programs. We have invited Dr. Jared N. Schwartz, the Director of the Department of Pathology and Laboratory Medicine, Presbyterian Hospital in Charlotte, to discuss clinical and laboratory findings that indicate HIV and syphilis coinfection in patients. This topic is timely, because many STD health care professionals have expressed concern that increased awareness about AIDS among some physicians has decreased their vigilance regarding other STDs such as syphilis. In addition, there is disagreement among some experts regarding appropriate treatment regimens. Dr. Schwartz can address these issues and is scheduled to speak on September 14, from 9 to 11 a.m.

The Executive Committee has also invited Dr. Russell Alexander, Chief of the Epidemiology Research Branch, Division of Sexually Transmitted Diseases, CDC, to speak on September 14, from 2 to 4 p.m. as part of a panel discussion on Congenital Syphilis and Pediatric AIDS. This workshop is being jointly sponsored by the STD, MCH and Social Work Sections. Dr. Alexander will discuss the current incidence of and trends in these diseases among children in North Carolina and the nation. The panel discussion will help to outline the role of public health programs in preventing these diseases through increased surveillance and targeted risk-reduction education programs. It is always exciting and worthwhile to work with other sections to present a program, and this year has been no exception.

The STD Section Business Meeting will be held September 13, at 1:00 p.m. During this time we will present the STD annual awards to those persons who have been recognized for their outstanding service and contributions to the Sexually Transmitted Disease program in North Carolina. INJURY SYMPOSIUM PLANNED

Injury is the fourth leading cause of death nationwide and is the leading cause of death for people between the ages of 1 and 45.

Responding to North Carolina's high rate of preventable deaths and disabilities by motor vehicle crashes, house fires, homicides, suicides, drownings, poisonings and falls, Governor James Martin appointed a task force on injury prevention. The Governor's Task Force is convening the first North Carolina Symposium on Injury Prevention and Control on November 6-7, 1989, in Raleigh.

The first day of the symposium will focus on injuries in North Carolina and feature discussions on ways to reduce and prevent death and disability due to injury. The following day's program will address childhood injuries. Please plan to join nationally recognized injury experts to learn what you can do to prevent these North Carolina deaths and disabilities.

This symposium is designed for local governmental officials, health and human service agency professionals, pediatricians and other medical providers, occupational and agricultural safety specialists, public safety personnel, and state and local policy makers.

The symposium will be co-sponsored by the Division of Health Services, the Governor's Highway Safety Program, the Injury Prevention Research Center at UNC-CH and the Division of Community Health Service, School of Public Health, UNC-CH.

LEGISLATIVE GOALS ON HOLD AS LAWMAKERS DEBATE BUDGET

A projected June 30 adjournment of the 1989 Legislative Session has been delayed by an impasse between the Senate and the House over funding for highway construction, pay raises for teachers and state employees, and other programs. Therefore, what we hoped would be a final report on the outcome of NCPHA legislative goals will be some "crystal ball forecasting," based on the best guesses of observers close to the legislative scene.

NCPHA's top priority, a bill creating a new Department of Environment, Health and Natural Resources, passed early in the House and is now "on hold" in the Senate Appropriations Committee. There appear to be no problems with approval of the consolidation plan at this point, according to DHS Deputy Director Chris Hoke, who said that major bills often are held for passage until the end of the session, sometimes used as "bargaining chips."

Until major budget issues are settled, the fate of most NCPHA legislative funding goals is still uncertain. Although the Senate's proposed expansion budget does not include many public health requests, the House version has not been submitted nor has a compromise version been reached. With a shortfall in state revenues this year, and legislators crying "no money," prospects do not appear bright.

Unfortunately, the Senate expansion budget did not include funds for either funding for local environmental health programs, our top funding priority, expansion of local health promotion and disease prevention programs, or AIDS prevention and education programs. While these may be included in the House version, again, this does not look promising.

Prospects are very positive, though, for a bill to expand Medicaid coverage for infants and pregnant women. The original bill included those whose family income is 185 percent of the federal poverty level, however, the final version will probably set the level at 130 percent.

A bill initiated by NCPHA to establish an independent Public Health Study Commission has, according to NCPHA Legislative Counsel Henry Jones, "passed scrutiny in all the committees where it has been heard and is now awaiting final dispensation in Appropriations."

Good news about the bill initiated by NCPHA to add local government employee representation to the State Personnel Commission: This has been ratified. The approved version specifies that one of the two members appointed by the County Commissioners Association be a local government employee hired under the State Personnel Act.

A bill to establish a statewide solid waste management plan was approved by the Senate and an expanded version received a favorable report from the Solid Waste Subcommittee of the House Infrastructure Committee. This must now be approved by the full committee and the House. Staff at the DHS Solid Waste Branch predict this has a good chance of passing.

A final report on the 1989 Legislative Session will be distributed at the annual meeting of NCPHA in September.

SOUTHERN HEALTH ASSOCIATION UPDATE

The Southern Health Association presently has 237 members and has recruited 73 new members during the past year.

Eleven states are represented in the Southern Health Association and it is hopeful that Georgia will again become an affiliate member. The Southern Health Association seems to have turned a corner and is now a viable organization with a newsletter entitled Southern Health Update, a part-time executive secretary, and active participation in regional health problems in the Southeastern United States. One of the goals is that the Southern Health Association will soon be the regional representative for the American Public Health Association similar to the old Southern Branch. I believe great strides are being made in that direction. The Southern Health Association passed the following resolutions:

- 1. Support for people with HIV infection and associated diseases
- 2. Advocacy for indigent and rural health care
- 3. Reaffirm support for family life education
- 4. Tennessee recognized on its 50th anniversary
- 5. Florida recognized on its 100th anniversary

Two people known to us in North Carolina received awards. Barbara Ann Hughes received the Meritorious Award and Earl Fox from Alabama received the Maternal and Child Health Award. Senator Robert C. Scott from Virginia received the Legislator Of The Year Award, the Ficquett-Holley Award went to Mary Emily Trotter, a nurse from Tennessee, and the Charles C. Jordan Award went to J. Blain Hill also from Tennessee.

The Southern Health Association is open for invitations for its meeting in 1991. The next meeting of the Southern Health Association will be on May 23-30, 1990 at the Hilton Hotel in Myrtle Beach, South Carolina. I would like to encourage members of the North Carolina Public Health Association to join and support the Southern Health Association.

THE PUBLIC HEALTH AWARENESS CAMPAIGN

"PUBLIC HEALTH: DISARRAY OR CHALLENGE?"

Program Plans for the 1989 Annual Meeting

The National Academy of Sciences, which advises the U.S. Congress on health policy matters through the Institute of Medicine, established a committee in 1985 to study the current state of public health and to make recommendations for the future. The report of this committee, commonly referred to as the Institute of Medicine (IOM) Report, is now available and is the focus of discussions to gain input from those involved in public health delivery services. The overall theme for the 1989 annual meeting has been taken from this report — "PUBLIC HEALTH: DISARRAY OR CHALLENGE?"

Due to the impact this report will have on all programs within public health, the findings will be the topic for a panel discussion in one of the general sessions during NCPHA. The School of Public Health is planning forums in different areas of our state to review the report and to elicit recommendations for change. The forums will be an opportunity for individuals to be heard. Information from the forums will be summarized and will be part of the NCPHA Panel presentation at the annual meeting. Coordinating with the School of Public Health on this topic will prevent duplication of efforts. The IOM report encompasses many areas, and the presentations being planned will enhance the dissemination of information and the opportunity for participation.

Although the report found the public health system in a state of disarray, North Carolina is accepting the challenge to study the report's recommendations to develop strategies for implementing a comprehensive health program that would link the work of the public and private sectors in meeting global health needs.

This mission not only has relevance for public health as a statewide agency, but also will influence the future direction of health departments in both rural and urban areas, and will have an impact upon all disciplines involved in the health care system and upon the training of professionals entering the field of public health.

The NCPHA Program Committee is working to bring keynote speakers who will address the broad interests of our membership. In addition, Section Program Chairpersons met early in February in preparation for their task to provide a wide variety of programs and workshops. There will be something of interest to each of you.

THINK TANK MAKES RECOMMENDATIONS TO IMPROVE AND EXPAND NCPHA'S GOVERNANCE AND FINANCIAL DEVELOPMENT



President Ann Wolfe commends Leslie Brown for the work of the Think Tank Task Force, which he chairs.

In 1987, the Think Tank Task Force was appointed by Stacy Covil, President. The NCPHA Think Tank Task Force charge was to make recommendations to the Governing Council which would enhance the Association's ability to positively influence the public's health in North Carolina by encouraging professional growth and development among Association members; by enhancing the Association's role in advocating, promoting, and supporting public health; and by enhancing the Association's ability to shape and influence public health policy, programming, and practice in North Carolina. The Task Force completed its first year of work by filing a Summary Report to the Governing Council in April, 1987. The Report contained key resolutions on Association governance, financial development, and staff development. The Report recommended in part:

(1) The Association bylaws be amended:

- "To provide that the president-elect have increased responsibility in assisting the president in developing and maintaining relationships with other public and private health, educational, and service organizations and in serving as a direct liaison between the president and other organizations, groups, and persons interested in public health."
- (2) "The Association take affirmative steps to promote strategic planning, financial development, and staff development. Such steps to include: (1) amend bylaws to revise and further develop duties and responsibilities of elected officers; (2) expand and diversify Association revenue sources; and (3) to plan for the eventual recruitment, selection, and hiring of a professional staff to perform the Association's executive and administrative functions."

These resolutions were subsequently acted upon favorably by the Governing Council.

In 1988, the Task Force continued its efforts and submitted specific recommendations on the matters of financial development and staff development to the Governing Council in June, 1988. The specific recommendations called for:

— The Governing Council to establish a Professional Staff Development Fund within the Association's budget.

— A \$5.00 increase of regular membership dues per member and that \$5.00 per regular member be transferred to the Professional Staff Development Fund.

— The Membership Committee to be charged with the task to plan, implement, and maintain a membership drive with a goal to increase membership by a total of 600 members by January 1, 1990.

- The Governing Council to plan, manage, and conduct a

Professional Staff Development Fund campaign to solicit members for voluntary contribution to the Professional Staff Development Fund with a goal to raise \$25,000 for the Fund by July 1, 1989.

The Governing Council to authorize the development of a proposal to seek up to \$50,000 a year for the Professional Staff Development Fund for a two-year period from a North Carolina-based foundation or other appropriate source. The goal would be for such funding to be available to the Association by July 1, 1989.
 The Governing Council adopt Staff Development Implementation Plan for a two-year period. The plan should cover the nature and scope of executive functions to be internalized into the Association and should be consistent with financial resources available in the Professional Staff Development Fund to the Association for such purposes.

Governing Council approves plan to increase financial resources for organization

The Council approved the recommendations at its June 8 meeting. Taken as a whole, the recommendations provide new and innovative approaches to building the financial base for the Association so that it can acquire a full-time staff to pursue the Association's public health mission.

By approving the recommendations, the Governing Council created the framework for improving and expanding the financial base for the Association. Some of the recommendations are self explanatory; others require comment. Consider the recommendation concerning soliciting the Association membership for voluntary contribution for the staff development fund. The idea here is that on a one-time basis, the membership of the Association would be asked to make voluntary contributions to the Association for the specific purpose of building the Staff Development Fund. Contributions of any amount would be welcomed. A successful campaign would mean that the Association would have significant resources, in combination with the successful completion of the other activities, to move forward with recruiting, selecting, and hiring a full-time staff. From the perspective of the Task Force, the voluntary contributions approach may lay the groundwork for planned giving opportunities (wills, trusts, endowments) for the Association in the future.

The idea of developing a proposal to seek foundation support for the staff development fund merits further comment. Here, the idea is to solicit the financial support of a North Carolina-based foundation to help the Association take the bold step of positioning itself to serve public health now and in the future. The Task Force recognizes that to accept financial assistance from a foundation will bring with it certain terms and conditions. Clearly, it will be the responsibility of the Association's governing body to enter into such a relationship with the best interest of the Association, its members, and the public health community in mind. The demonstrated competency and achievements of the Governing Council over the years should allay any fears that the Council will strike a "bad deal" for public health.

Finally, the requirement that the Governing Council adopt a Professional Staff Development Implementation Plan will serve as a mechanism for the Association to carefully review and take stock of the success of the several efforts and chart a course for future actions based on the financial resources available and the long-term goals of the Association.

As we approach the Year 2000, the challenges facing public health and those who practice it are enormous. To meet the challenge will require skilled, up-to-date professionals representing and articulating public health issues and concerns and a strong, independent, and viable organization to serve as an effective advocate for public health. Strengthening the administrative and executive functions of the Association by having a full-time paid staff serving under the Governing Council will effectively position the Association for the future.

DENTAL HEALTH

The Dental Symposium, which was held in Durham, proved to be the highlight of the Seventieth Anniversary. The workshops and discussion groups provided a vehicle for voicing the many concerns regarding dental public health as a whole. A compiled report of the meeting should be forthcoming.

All dental staff are gearing up for Children's Dental Health Month. The Dental Health Section is collaborating with the NC Department of Public Instruction, the NC Dental Society, and local dental programs in sponsoring the North Carolina Super Smiles contest. ENVIRONMENTAL HEALTH

During 1988, North Carolina experienced 446 cases of Hepatitis A, of which 123 were food related. Hepatitis A is a viral infection transmitted by the fecal-oral route: food contamination and person-to-person contact.

Bad foodhandling practices and poor personal hygiene are the culprits. Unlike bacteria associated with foodborne diseases that depend upon proper time and temperatures after contamination, the Hepatitis A virus does not grow in food. The virus is comfortable in cool, moist environments and can survive temperatures up to 185 degrees F. Satisfying regulated food temperature requirements (45 degrees F or below and 140 degrees F and above), is not the control measure. The violations that have occured to produce Hepatitis A food poisoning are the process contamination of foods to be served uncooked and the post-contamination of cooked foods. Hot and cold self-serve food bars are excellent bedding areas for the Hepatitis A virus. Contamination can occur via food service personnel in the restaurant and by the customer.

Control can be simple and calls for a return to basics. Foodhandlers — that includes the public — must wash their hands thoroughly after each visit to the toilet and whenever their hands become soiled. Sanitarians must properly enforce the rules and regulations during inspection when violations are observed and must also take every opportunity to educate food service personnel and the public.

Helen spent the last ten years of her life as a true crusader for the concept of health promotion, and sponsored numerous projects such as an aerobic and water exercise program for the elderly which she personally led.

In 1988, a third award was established to recognize an individual from within the community for demonstrated leadership, exemplary concern for their community, and an innovative approach to adult health promotion.

NURSING SERVICE'S DOLAN AWARD

Public health nursing excellence was exemplified in the life and career of the widely beloved Margaret B. Dolan. A native of Lillington and a graduate of Georgetown and Columbia Universities, Mrs. Dolan went on to become a prominent national leader. She retains the unique distinction of being the only person to serve as president of three national health organizations: The American Nurses' Association, the National Health Council and The American Public Health Association. During the presidency of John F. Kennedy, she was appointed to serve on the National Advisory Health Committee and continued to serve in that capacity under President Lyndon B. Johnson. She was also appointed as Nursing Consultant to the Surgeon General, Department of the Army, from 1969-1971.

Although her service to national health was considerable, including membership on the Board of Directors of the National Assembly for Social Policy and Development, the people of North Carolina also felt the impact of her contributions. In the early forties, she worked as a staff nurse and VD Clinic supervisor at the former City Health Department in Greensboro. After a year as Tuberculosis Nursing Consultant for the U.S.P.H.S. Tuberculosis Program and four years as Generalized Public Health Nursing Supervisor and Tuberculosis Nursing Consultant for Baltimore County Health Department, Maryland, she became a faculty member in the Department of Public Health Nursing at the University of North Carolina. She taught extension courses for public health nurses during the early fifties and served as a consultant for community health surveys. In 1959 she became Chair of the department. Author of numerous publications and papers, she served as a leader of the public health nursing profession in the state and across the nation until her death in 1974.

The Public Health Nursing Service Section unanimously established the Margaret B. Dolan Award in 1972 to recognize public health nurses committed to quality nursing care, excellence in public health nursing service, leadership in providing service to citizens of North Carolina, contributions to the improvement of community health, and professionalism as a style of life.

"She was one of the most dynamic and energetic women I have ever known," states Kate Williamson of Fayetteville, first recipient of the Margaret B. Dolan Award in 1973. Each of the fourteen persons to receive the award since that time has spoken of the profound honor it has been to have this highest distinction in North Carolina public health nursing service conferred by one's peers.

The Public Health Nursing Service Section urges anyone knowing a dedicated public health nurse deserving professional recognition to submit her name for nomination. SEXUALLY TRANSMITTED DISEASES

The STD Section Executive Committee has been hard at work this year planning for the upcoming NCPHA meeting in Charlotte. We want to provide workshops that will be informative and responsive to the current concerns identified by many STD section members.

Jim Fowler, Branch Head, STD Control, Division of Health Services, has expressed his concern that, as a result of the increase in primary and secondary syphilis and PPNG and the concurrent decreases in federal and state staff, priorities in treatment and patient follow-up will have to be reassessed. For example, in 1986 there were no cases of congenital syphilis reported in North Carolina; however, in 1987, 2 cases were reported and in 1988, 7 cases were reported, two of whom died. As Mr. Fowler points out, it is clear that primary and secondary syphilis must remain a number one priority for the STD Control Program. Similarly, in 1988, over 500 cases of PPNG were reported in this state, compared to 220 reported cases in 1987. and 93 reported cases in 1986. The recommended treatment for PPNG is expensive, and patient follow-up is aggressive and timeconsuming. As PPNG increases, previous priorities such as the Gonococcal PID Program remain important but cannot receive as much attention as in the past. The STD Executive Committee feels that programs responding to some of these concerns should be offered this year during NCPHA's annual meeting. We hope to find presenters who will increase our awareness of the current challenges facing the STD Control Program in 1989.

The STD Section currently has 74 members. I would like to take this opportunity to encourage each member to be on the look-out for potential new section members and to encourage them to join. Remember to tell them that not only do we try to provide informative programs, but also — based on the increasing participation during our social hours — to provide good company, conversation and friendship.

Also section members are asked to begin thinking about those co-workers who provide outstanding service worthy of recognition. When the Awards Committee meets in the spring, they want to hear, loud and clear, from section members concerning those persons who deserve an award for excellence. In the very near future, STD Section members will receive a newsletter outlining the award process in further detail.

DEVELOPMENTAL REHABILITATION

At its first meeting of the new year on January 26, the Executive Committee of the DR Section of NCPHA implemented an active plan of involvement for 1989.

NCPHA Dual Officer Slate Resolution. At the NCPHA Annual Meeting in Winston-Salem last September, the DR Section voted to draft a resolution for consideration by the Governing Council to require that a dual slate of officers be submitted for election. Additionally, this resolution will suggest that a mailed, written ballot be taken in place of a voiced vote from the floor. This resolution will be presented for consideration at the second Governing Council meeting in 1989.

Eastern NCPHA and Western NCPHA Workshops. Following the successful venture into WNCPHA last year with a wellattended workshop on Malpractice and Liability, the DR section again plans to hold a workshop in conjunction with WNCPHA. The workshop topic has not been identified as yet. Ira Palmer, DR Section Treasurer, will coordinate this workshop.

Josephine Cialone, DR Section Vice-Chairperson, will coordinate a workshop sponsored by DR at ENCPHA. The topic from last year's WNCPHA will likely be repeated at ENCPHA in '89.

The DR Section topic for the statewide NCPHA Convention has not been determined as yet. Josephine Cialone will also coordinate this program. According to past tradition, the DR Section Business Meeting will likely be keynoted by an invited legislator.

Legislative Action Network Involvement. Our representative, Mildred Council, attended the first Network meeting and also will represent our section at the Public Health Leadership Conference. Our Section supports the efforts of this network and is a contributor to this year's conference.

The Leo M. Croghan Scholarship Fund. The DR Section is undertaking the development of a scholarship fund in memory of Dr. Leo Croghan, former DEC Director in Fayetteville. The Section has appointed a committee to study the establishment of this fund. Representation on this committee will be solicited from the DEC Director's Association as well as from both state and regional offices. PUBLIC HEALTH AWARENESS CAMPAIGN

The Division of Health Services — the state health agency in North Carolina — is undertaking a multi-faceted educational initiative for the purpose of raising the awareness of the public and of community leaders of public health services, accomplishments and problems. The initiative is better known as the Public Health Awareness Campaign. The campaign is planned for implementation during the 1989 calendar year. The Division's Office of Health Education and Communication (OHEC) is responsible for planning and managing this initiative, with Jim Thorp, the OHEC health communication and marketing specialist, assuming the lead role.

The components and strategies of this initiative include: five posters during 1989; a number of radio PSAs to reinforce and expand the poster themes; printed publications to use in marketing the services and in developing press releases; a public health calendar '89 for staff and for community leaders; billboards across the state; windshield sun shades with the campaign slogan: "Public Health — Pulling Together for Healthy Living"; and a video on public health services.

Local health departments have individually in the past undertaken activities to explain their services to various community groups. This, however, is the first time that the state has taken the initiative, on behalf of and in collaboration with all local health departments, to carry out a coordinated statewide campaign, over an extended period and with tools and products developed by the state Division of Health Services. This marks the increased emphasis by public health agencies on marketing public health services and the impact they have on people's lives. Realizing such an impact could lead community people and leaders toward stronger interfacing with health departments for the purpose of protecting and improving the health of North Carolinians.

Finally, the President-Elect is involved with the Executive Committee, Governing Council and other Public Health organizations which work closely with NCPHA.

I am excited about being President-Elect of NCPHA and look forward to this year and next as I serve you. There is so much we can do to help other people.

PUBLIC HEALTH STUDY COMMISSION ADDED TO NCPHA LEGISLATIVE GOALS

Initiation of a bill to establish a Public Health Study Commission will replace, for the present time, legislative action on a bill to mandate minimum salary levels for county employees hired under the State Personnel Act. A decision to defer action on the salary bill was approved at the January Governing Council meeting after Legislative Committee members reported on efforts to accomplish this goal by working with a County Commissioners Association task force.

The salary issue remains a top legislative priority for NCHPA, and the decision not to introduce a bill in this session in no way reflects a decreased interest in the problem. The Local Health Directors Association and other public health groups encouraged NCPHA to join them in working through the task force, believing this to be the most effective way to accomplish this goal. This study group will review and collect data to document problems caused by low salaries for county health, social services and mental health employees. NCPHA representatives on the task force are Linda Parker, Legislative Committee chair, and Bob Parker president-elect.

Update on Other Legislative Goals

•Department of Health and Environment. Although the bill proposing consolidation of health and environmental programs has not yet been introduced. Rep. Joe Hackney said he expected the bill to follow recommendations of the Environmental Review Commission to transfer all Division of Health Services programs intact into the new department. Concern has been raised about one proposal discussed that would keep maternal and child care programs out, perhaps even creating a new department and will follow this bill closely when it is introduced to see that it reflects the needs and interests of the public health community.

•Bill to add two active local government employees to the State Personnel Commission. This bill has been drafted and is expected to be introduced by Rep. Beverly Purdue by the end of February.

•Mandated Solid Waste Management Plan. The Solid Waste Study Committee has introduced a comprehensive package of bills that includes one to mandate the development of a statewide waste management plan by January 1991 (SB111). Other bills introduced would create new positions in the Solid Waste Management Section, establish a revolving loan fund, enable local governments to enact solid waste ordinances, and permit county commissioners to level landfill disposal fees on municipalities and municipal residents in the county.

•Study Commission on Injury Prevention and Control. In January, Governor James Martin established a Governor's Task Force on Injury Prevention under the leadership of Dr. Thad Wester, DHS Deputy Director, Mr. Bob Parker represents NCPHA on the group, and Dr. Ann Wolfe will staff the task force. NCPHA will work with this group to determine the most effective timing and strategy for introducing a bill for a legislative study commission on this topic.

•Smoking Policies for State Government Buildings. Members of the Legislative Committee are working with representatives from the North Carolina affiliates of the Heart Association, the Cancer Society and the Lung Association to draft a bill and to find legislators who will introduce it. Several legislators approached have been sympathetic to the issue but unwilling to agree to sponsor it, citing the current leadership shake-up in the House and Senate as an unfavorable climate before which to bring such a controversial bill. Many have implied, too, that introducing such as bill may negatively affect other bills NCPHA is supporting. One major factor related to the success of even getting this bill introduced will be the stand taken by the State Employees Association (SEANC), which previously has opposed a smoking policy bill. Linda Parker, Legislative Committee chair, is scheduled to meet with representatives from SEANC to encourage their support.

•NCPA Funding Priorities. Top priority items on NCPHA's leglislative agenda were DHS expansion budget requests in five program areas: Local environmental health services, maternal and child care, health promotion and disease prevention, AIDS and other sexually transmitted diseases, and indigent care. These requests were not funded in the governor's proposed budget. NCPHA is working with the Association for Local Health Directors to initiate indiviual bills for three of these—maternal and child care, environmental health, and health promotion. Funding for AIDS education and prevention programs and indigent care will be included in bills recommended by legislative committees that have studied these issues during the past year.

Our president, Dr. Ronald B. Tucker, has appointed and charged various committees of the association to continue to work to bring ANCBH to its fullest potential. The American Public Health Association is publishing a new newsletter titled *Government Relations Highlights*. NCPHA SCHOLARSHIP AVAILABILITY 1989-90

Applications for NCPHA Scholarships must be received by June 16, 1989. Scholarships are awarded to present or prospective workers in public health in North Carolina for graduate or undergraduate study or for technical study in the case of the Management Support Scholarships. Awards can be used for prerequisites or training through a regular academic program in an accredited educational institution which would advance the individual's competence in public health work.

Applicants must state, in writing, an intent to work in a North Carolina public health agency for 2 years following completion of training. Applicants should be or become a paid member of NCPHA.

Awards are based upon: (1) Acceptance at an accredited educational institution; (2) Potential of service to people of this State; (3) Reasons for seeking the training; (4) Financial need. Past awards have been granted to persons training in various public health fields; such as, environmental, nursing, health education, social work, counseling, administration, nutrition, biostatistics, dental, etc.

The amount of the scholarship awards usually ranges from \$300.00 to \$500.00 per awardee. For the academic year 1989-90, the Scholarship Committee expects to make the following awards: The Elizabeth Holley Memorial Scholarship to a public health nurse; two Management Support Section Scholarships to management support workers; three or more general scholarship awards from NCPHA (All public health professions are eligible for these scholarship awards.) Master's Degree Programs For Working Health Professionals in Health Administration and Public Health Nursing Starting in Charlotte in August

The School of Public Health of the University of North Carolina at Chapel Hill is accepting applications for its twelfth off-campus Master of Public Health program to begin August 1989 in Charlotte. The program offers persons in western North Carolina an opportunity to receive graduate training in health administration or public health nursing while continuing to work full time.

The programs require 36-39 credit hours for graduation (12-13 courses). Approximately 10 of these courses will be taught at the AHEC Center in Charlotte. The remaining coursework will be offered either on weekends, or as independent guided-study modules. Courses taught in these formats will require students to attend classes on the Chapel Hill campus for two-day periods up to four times a semester. Public health nursing students will have field placements arranged to meet individual needs.

Students should meet the following academic requirements for admission: (1) Bachelor's or higher degree from an accredited college or university; (2) Grade point average of 3.0 or better in the *major* subject; (3) Score of 1,000 on the combined verbal and quantitative parts of the Graduate Records Examination (GRE).

In addition, each program has requirements related to professional experience.

Interested persons are urged to begin the application process as soon as possible. Experience has shown that it may take as long as 3 months before all college transcripts, GRE scores and recommendations are available to the admissions committees. Applicants who do not have a current GRE score are encouraged to register for the exam at the earliest opportunity. This examination is administered statewide on April 8th and June 3rd.
