Executive Director Update

I had originally planned a different written update for this newsletter. Then at our recent Executive Committee and Governing Council meetings, Dr. Vann asked our leadership members to share things that she felt like were worth

highlighting for NCPHA during a session that she was invited to at the APHA Annual Meeting. The amount of good work was so encouraging, and the moment for all of us to reflect on all the great things happening through NCPHA led me to change my update. As we rattled off a long list of accomplishments, I wanted to share the highlights here:

- With almost 1,500 members, NCPHA is the largest APHA affiliate in the country
- NCPHA recently held the first ever NC Public Health Data Summit, and is in the planning stages for another data summit in May 2023
- NCPHA was a founding member and financial supporter of Care4Carolina, a key advocacy organization that helped drive North Carolina forward toward Medicaid Expansion

- NCPHA has established a strong and growing BIPOC Caucus to make sure that black, indigenous and people of color working in public health are supported and celebrated within our association
- Our Young Professionals Section has used their time and energy to conduct fund raisers and charity drives during our fall educational conference
- Our Social Work Section recently raised sufficient funding to establish an endowment for the Kelly Spangler Public Health Social Work Scholarship
- NCPHA has recently received grant funding to participate in the All of Us Research program, a first-ever environmental/climate impact program for NCPHA in partnership with the City of Charlotte, and has recently applied for additional grant funding to support our advocacy efforts

This list is not comprehensive, and I'm sorry to all of you working on other great things that I missed. I'm staggered by all of this work, and I'm so thankful for all of our NCPHA members and for the work that you all do to make this association great. I'm thankful to work for you.

General Assembly Takes a Break—Funds Several NCPHA Priorities in 2023 Budget



The North Carolina General Assembly has finally taken a break after one of the longest "long" sessions in recent years. The legislature convened in mid-January and recessed in late October. Normally the legislature would adjourn after so many months work, but this year they are breaking for one-month periods in case there is a need to return to consider veto overrides or other urgent business. The General Assembly will reconvene on April 24, 2024, for the "short" session.

The short session in generally intended for budget adjustments and a few pieces of unfinished legislative business, however, legislative leaders are already talking about several major legislative initiatives for 2024, including casino gambling and legalization of medical marijuana. It remains to be seen if the short session will truly be short. NCPHA's Advocacy Committee will be actively involved in advocating for important public issues in the coming session.

The legislative session of 2023 proved to be a fairly good year for public health with several important initiatives supported by NCPHA contained in the budget bill.

With of the approval of the state budget in early October, North Carolina will expand Medicaid to cover hundreds of thousands in the coverage gap. Medicaid Expansion is a tremendous investment in the health of our state, and it means that billions of dollars will come to North Carolina each year to provide health insurance and to help keep doors open to health departments, clinics, facilities, and providers in rural communities. Medicaid Expansion has taken over a decade of work by a large coalition of advocates, including NCPHA. On December 1st DHHS will begin taking applications from adults ages 19-64 who qualify for Medicaid. For information and assistance with

On the tobacco control and prevention front, the state budget appropriates \$11,250,000 in nonrecurring funds in each year of the biennium from the State's settlement with JUUL Labs, Inc. for evidence-based electronic cigarette and nicotine dependence prevention and cessation activities. This will allow the state's Tobacco Control Branch to continue its work to prevent and reduce youth smoking and electronic cigarette use.

The budget also includes \$3 million in recurring funds plus an additional \$3 million in nonrecurring funds in the first year of the biennium to offset the reduced-price breakfast and lunch programs in schools participating in the National School Lunch Program and the School Breakfast Program. Clearly, access to nutritious meals in the school setting is an important aspect of childhood health and learning.

In addition, Local Health Departments will receive a \$4.3 million appropriation in each of the next two years, divided equally as \$50,000 per health department. These are flexible funds intended to be used to meet any public health need. NCPHA and NCALHD advocated for a larger recurring appropriation for health departments during this session, but are encouraged to receive this funding and will continue to advocate for public health funding in future sessions.

The Division of public health also received recurring funding to establish a travelling training team for the CIT training program. The availability of this training team should allow for a reduced time to train local environmental health staff and will help with quicker onboarding of local environmental health workforce.

Mecklenburg County PH collaborates with AC&M

Mecklenburg County Public Health is working with AC&M Cultural Marketing to design an educational campaign promoting both flu and updated COVID-19 vaccines to County residents. The media campaign will share this message using digital ads on social media, radio and television, and electronic displays and print ads in newspapers, magazines, and large outdoor displays including billboards and public transit.

The campaign launches as we head into fall and winter, when flu and COVID-19 and other respiratory viruses circulate more and we travel and gather to celebrate holidays. Vaccination can keep illness from disrupting our lives and our celebrations. Flu and COVID-19 vaccination is especially important for older adults and people with pre-existing conditions who are at higher risk of developing serious complications from these viruses, but even healthy people can experience longterm health problems. Vaccines reduce the risk of all negative outcomes for all people, from the very young to the young at heart.

2024 Public Health Social Work Conference

The 2024 Public Health Social Work Conference, presented by the North Carolina Public Health Social Work Continuing Education and Training Advisory Committee (CETAC), has been renamed to the Kelly Spangler Public Health Social Work Conference. This is in memory of Kelly Spangler, NC Public Health Social Worker, CETAC and NCPHA member and fierce advocate for the citizens of North Carolina.

The next conference will be on March 28, 2024 at The Conference Center at Guilford Technical Community College in Colfax, NC. The planning committee, comprised of several NCPHA Social Work section members, is working to provide a day of learning and networking for public health social workers.

Nursing Section



The Public Health Nursing Section had a great Fall Educational Conference this year. Sessions ranged from our usual info-packed legislative session and our update from the Office of the Chief Public Health Nurse to sessions on harm reduction and reproductive coercion, as well as a new roundtable-format session this year which we dubbed Collaboration Station. We heard from our membership that there was an array of topics poignant to the current role of the public health nurse, and recognized that in many of these topic areas, we are our own best experts. We set up stations for facilitated conversation to share best practices and challenges about recruitment and retention, sheltering, and mentoring, along with art therapy and pet therapy stations to carve out an opportunity for self-care. The feedback received from this session was overwhelmingly positive, and we hope to continue to offer this platform for collaboration on relevant topics at future conferences.

During our Business Meeting, we elected a new slate of officers and held a vote to change the name of our section from Nursing to Public Health Nursing. This highlights our specialty as public health nurses and better aligns us as a state affiliate, mirroring the Public Health Nursing Section of the American Public Health Association. This section name change was approved by the NCPHA Governing Council on November 9th.

Congratulations to Heather Willis and Jessica Hardy for receiving our Joy Reed Scholarship and Nursing Scholarship, respectively. Congrats also to Shenell Little for being the recipient of the Direct Service Award in recognition of her leadership. This year was the 50th anniversary of the Margaret B. Dolan Award, and it was an honor for our section to present this award to ALL North Carolina public health nurses. Given the leadership qualities celebrated by this award (commitment to quality care, accessibility, leadership, advocacy, and awareness), it only made sense to recognize our entire public health nursing workforce for the historic efforts we have put forth over the past several years to ensure our communities' health.
