Efforts to Streamline Advocacy Activities

- "Rapid Response" network within greater APHA needed to respond quickly to PH threats.
- Organizational analysis / consultation underway to make recommendations for streamlining.
- PHN Section generated database of members, their expertise, willingness to lead advocacy efforts in their areas of expertise.

Major Initiative #1: RWJF FON 2020/2030 - Nursing & SDOH

- The Future of Nursing: Leading Change, Advancing Health (2010) - RWJF/IOM Report Released
- IOM Process little opportunity for public input; predominantly closed meetings
- Eight Recommendations
 - Emphasis on expanding nursing care in communities
 - No recommendations to support PHN workforce
- Recommendation uptake extensive; has driven a number of subsequent initiatives involving nursing



FON 2020-2030: Context

The National Academies of SCIENCES ENGINEERING MEDICINE

The Future of Nursing 2020-2030

- (NASEM; previously, IOM)
- Launched in 2019
- Emphasis on nursing's role in addressing health equity, and therefore Social Determinants of Health (SDOH)
- Aligns with RWJF's Culture of Health (CoH) Initiative¹

FON 2020-2030: Processes

- NASEM sponsored by RWJF to generate report
- Public input required, but options for input vary
- Minimal transparency in committee selection process and speaker/presenter selection process
- Discourse tightly controlled
- Addressing SDOH clearly public health, and PHN concern

PHN Section Engagement

- Launch of FON 2020/2030 in March 2019
- How to ensure PHN input into process discussed at PHN Section mid-year meeting (March, 2019)
 - with Dr. Georges Benjamin, Executive Director, APHA
 - with PHN Section leadership team
 - Significance of concerns varied among leadership team; ultimately team approved developing strategy for engaging with FON 2020/2030



FON 2020/2030 Context

- Approaches for achieving health equity
 - "Downstream", individual approaches consistent with traditional healthcare system attempts.
 - Tackling SDOH must play large role to be effective.
 - SDOH conceptualization differs from public health perspective and U.S. 'healthcare' system perspective.
 - Conflating of SDOH (racism, educational or housing opportunity, etc.,) with intrinsic, individual characteristics (race, education level, homelessness, etc.,)

FON 2020/2030 Context

Consequences of FON 2020/2030 report conflation of within-individual with system-level origins of SDOH, and offering predominantly 'downstream' solutions to achieve health equity could be disastrous for socially or economically disadvantaged (SED) groups.

FON 2020/2030: Context

- Consequences of FON 2020/2030 report conflation of within-individual with system-level origins of SDOH, and offering predominantly 'downstream' solutions to achieve health equity could be disastrous for socially or economically disadvantaged (SED) groups.
- Historically, acute care nurses have more limited understanding of SDOH; most on FON committee
- Well-known public health scholars also on committee

Strengthen Investments in Public Health: Since 2008, the local public health departments alone have lost more than 55,000 public health jobs, which include nurses.² This drastic shortage of public health professionals has been brought into stark relief during the current crisis. We must not only provide an immediate injection of funding to bolster the public health nursing workforce, but long-term investments in a national public health service pipeline of nurses and other health care professionals.



ANA Support for PHN During COVID-19

- Requested a written statement from ANA that "encourages state nursing associations to advocate for, and state departments of health and local health departments to use a substantial portion of the federal emergency funds to replenish the losses to the public health nursing workforce."
- "We are hoping to receive some support from ANA for our public health nurses (PHNs) who are also on the front lines of the COVID-19 response, and where we desperately need more of them to be as funds become available for hiring PHNs to engage in the contact tracing, testing, and other roles that they should be playing a major part in."



ANA Statement On Replenishing the Public Health Infrastructure and Public Health Nursing Workforce

Jun 24th 2020

"While all areas of the public health workforce are critical to protect the health of our population, our public health nursing workforce touches every aspect of health care and **community wellbeing**. Possessing a select set of knowledge and skills, public health nurses are the most nimble of the public health workforce –ready to assume a range of roles that span providing direct clinical services to collaborating with community members across sectors to integrate and coordinate care and leadership in a variety of public health arenas, such as health departments or community-based clinics, etc. With their interdisciplinary colleagues, our well-educated and licensed public health nurses play an integral role in narrowing disparities, improving health outcomes, and reducing disproportionately high morbidity and mortality rates among vulnerable populations due to preventable illness."

Dear Secretary Azar:

We are deeply concerned about the "Interim Guidance for Implementing Safety Practices for Critical Infrastructure Workers Who May Have Had Exposure to a Person with Suspected or Confirmed COVID-19," which was released by the Centers for Disease Control and Prevention (CDC) on April 8, 2020. The agency has substantially weakened its previously issued guidelines,^{1,2,3} and this will lead to an increase in the occupational spread of SARS CoV-2. The guidelines should be immediately rescinded.

During this pandemic, tens of millions of workers in the U.S. are classified as "critical infrastructure workers."4 There are now numerous COVID-19 outbreaks among these essential workers in long term care facilities, warehouses, meatpacking plants, and prisons. These outbreaks pose a serious risk to their co-workers, as well as the clients and inmates

who are at high risk for hospitalization and death. The designation as a "critical infrastructure worker" should result in extra levels of health

protection, not less protection than what is recommended for the general public. It is exactly because critical infrastructure workers are interacting with co-workers and the public that they require exceptional protections. It is necessary for their own health and so they can continue to provide critical goods and services, but also to prevent their coworkers from being exposed and threatening an entire critical infrastructure worksite.
