- Ideas for next year
 - Disaster preparedness from On Target
 - Teen Pregnancy Prevention Initiative- a panel was suggested, as well as information about curricula used/how it is implemented, successes/challenges).
 - Columbus County and Martin-Tyrrell-Washington are doing great work with teens. Lakecia will reach out to these agencies.
 - A self-care presentation was suggested (maybe as a component of the conference).
 - Sessions that offer tangible skills are desirable. NC SOPHE had an epilepsy talk and a CPR/First Aid certification.

- ECU Health is a stroke program partner and recent award winner. They have a stroke awareness campaign and educational video.
- 2024 political issues (minors right to consent to contraception/STI treatment)
- Citizens for Public Health/panel on major public health concerns for 2024 (opioid settlement money, Tobacco 21)
- The next FEC will be in a triable community. We should consider partnering with BIPOC and reaching out to Public Health and Human Services with the Eastern Band of Cherokee Indians.
- Medicaid expansion- We should discuss this and consider increased immigration and language barriers. Are we prepared to address this from an equity standpoint? How can public health departments best prepare?

 - April 2024 event: health fair to advertise what agency and surrounding counties have to offer.
 - Partnership with Duke clinical trials coordinator- they are working towards offering first aid/CPR/AED in rural churches.
- Kathie Cox (Scotland County Health Department)
 - American Diabetes Month and World Diabetes Day are in November. Kathie and Janna are working with parks and recreation to offer walking events/photo opportunities.
